

# MINUTES OF THE ROCKY MOUNTAIN DISTRICT CONVENTION 2010

COLORADO SPRINGS, COLORADO

June 26, 2010

After ascertaining that a quorum (15) was present, the 2010 Rocky Mountain District Annual Business Meeting was called to order by District Director, Peggy Williams at 7:27 p.m. June 26, 2010. **Horticulture Judges Chairman: Susan Bishop stated the National Chairman said Shreveport will have new challenge class pages revised soon for the Judges manual Possibly RMD will hold a judges seminar next year.**

**Arrangement Judges Chairman: Carol Macon reported there are 3 new class offerings; Duke 10' x 20", Mini Duchess and Mini Princess.**

**There are no District classes or seminars planned at this time. Possibly in 2011.**

**Consulting Rosarian Chairman: Joan Franson reported the school held in October 2009 added 7 new CR's and that the district list will be updated. Perhaps a CR school will be held in Salt Lake City in 2011. Joan said the CR Manual is being updated and if we want any deletions or additions to let her know them so she can consolidate our District input and get the information to the committee working on the update. June Openshaw said she would like more organic information included.**

**Roses in Review: Cheryl Frechette told us it is time to respond to the RIR reports for 2010. Reports are due either by the ARS web site approach or sent to Cheryl by Sept. 26. The rating evaluation sheet and the list of roses being reviewed is in the July/August "American Rose" publication.**

**Awards: Mary Kirby announced that this year, Rocky Mountain District was presenting the ARS's second highest award and the Districts highest Award, the "Silver Medal Award" to the very deserving Margaret Drucker. A presentation was made to a surprised Margaret who graciously received the award.**

**Special Committee Reports: A newly formed committee to amend/revise the District Bylaws was appointed; Joan Franson, June Openshaw, Betsy Vasquez, and Peggy Williams.**

**Special Orders: June Openshaw of the Utah Rose Society issued an invitation to the District to host the 2011 Rocky Mountain District Convention and Rose Show. Tentative show date June 11th OR June 18th, 2011. The invitation was accepted.**

**General Orders: 2010-2011 budget presented by Opal Doane as listed on the Financial Statement sheet. Being no debate the budget as presented was adopted.**

**New Business: Carol Macon moved that RMD donate \$1,000. from our budget for a tile in the main hall at Klima. Opal Doane seconded the motion. Opal said \$300. could come from the fertilizer fund. After discussion the motion was amended to include the District Director and District Treasure be instructed to ask each society to contribute funds for the tile purchase. The newly amended motion was passed.**

**Announcements: Thanks to Carol Roman for getting the District website backup. She was here today taking pictures of the Rose Show for the website.**

**Jerry Macon thanked all who came to the show and dinner meeting. He said this show had possibly the largest number of entries recorded in RMD (387). Jerry invited people to join the garden tours on Sunday.**

**Peggy once again thanked the members of PPRS for hosting the 2010 Rose Show and Annual Meeting.**

**Being no further business or announcements, the meeting was adjourned at 9:32 PM.**
